NARRATIVE Unit 1 was traveling eastbound on East Smith Road at a high rate of speed, when it went off the roadway to the right. Unit 1 continued off the roadway right crossing over the driveways for both 3720 and 3710 East Smith Road. Unit 1 then began to rotate counter clockwise as it came back onto the roadway and crossed over the center line and eventually went off the roadway to the left before striking the ditch on the north side of the road. Unit 1 then proceeded back onto the roadway and struck Unit 2. Unit 2 had been traveling westbound and observed Unit 1 lose control, Unit 2 attempted to get out of the way of Unit 1 by crossing over the center line and leaving the roadway on the left side before being struck by Unit 1. Unit 1 came to final rest in the ditch to the east of the impact, and Unit 2 came to final rest in the westbound lane. Both driver and passenger of Unit 1 were taken to the hospital via EMS. Unit 1 was towed by World Truck, and Unit 2 was towed by Heidi's. Unit 2's driver declined medical attention.

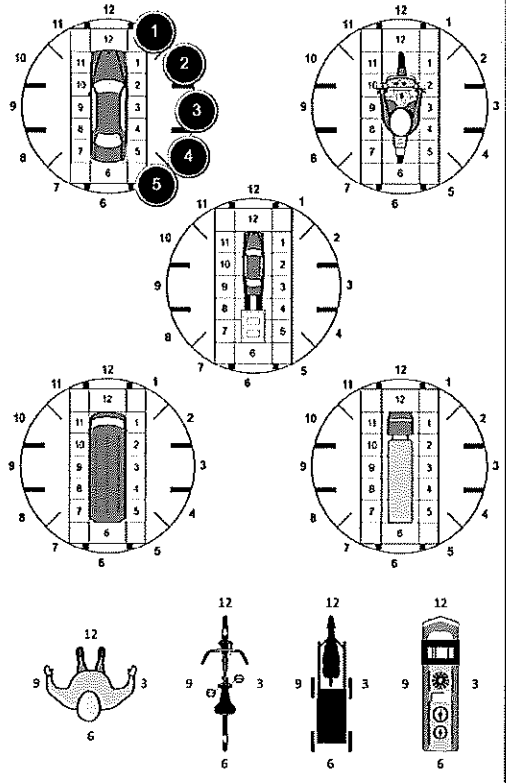
