NARRATIVE Unit #1 was stopped in traffic, eastbound on State Route 18 (Medina Road) at the intersection of Gateway Drive. Unit #2 was also eastbound on State Route 18 and approached Unit #1 from behind. Unit #2 swerved to the left in an attempt to avoid a collision, but struck Unit #1 from behind. The crash caused damage to both vehicles. Both vehicles were moved to a parking lot prior to law enforcement arrival. The Medina Township Police Department requested that the Montville Police Department complete this crash report due to call volume.

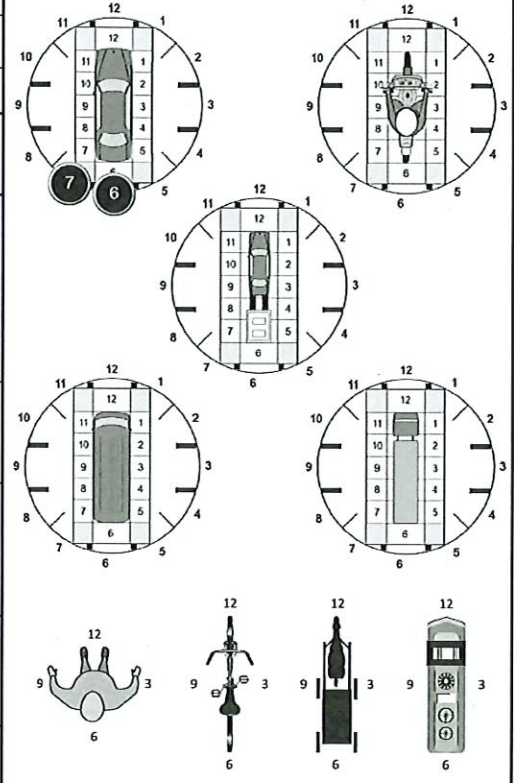

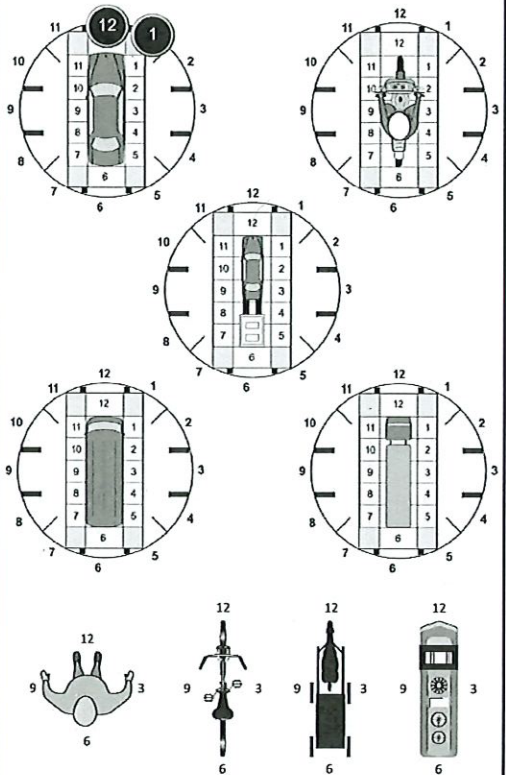
