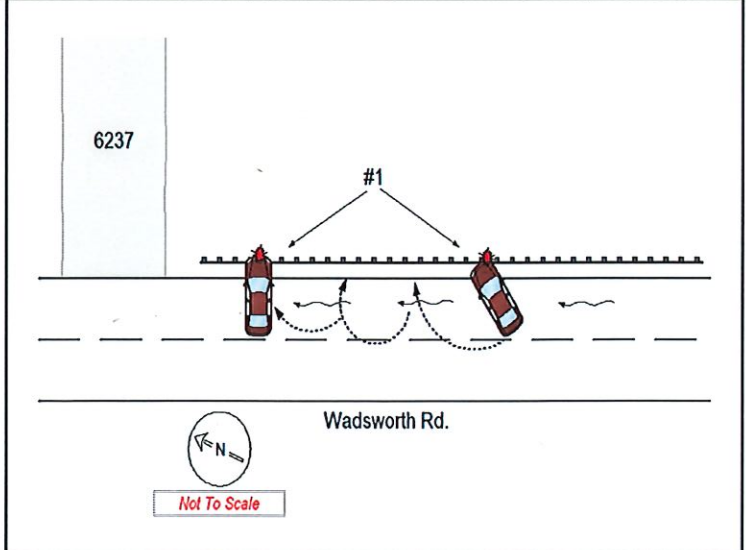

NARRATIVE
Unit #1 was northbound on Wadsworth Rd, just south of 6237 Wadsworth Rd. Unit #1 slipped on slushy, wet roadways and struck the face of the guard rail on the east side of the roadway. Unit #1 continued to spin and came to final rest with the front of the vehicle against another portion of the guard rail, 90 degrees to the lane of travel. No other objects were struck during the loss of control. No injuries were claimed at the scene. Jon's Towing arrived for recovery of Unit #1, the driver of which was cited for ORC 4511.202.
