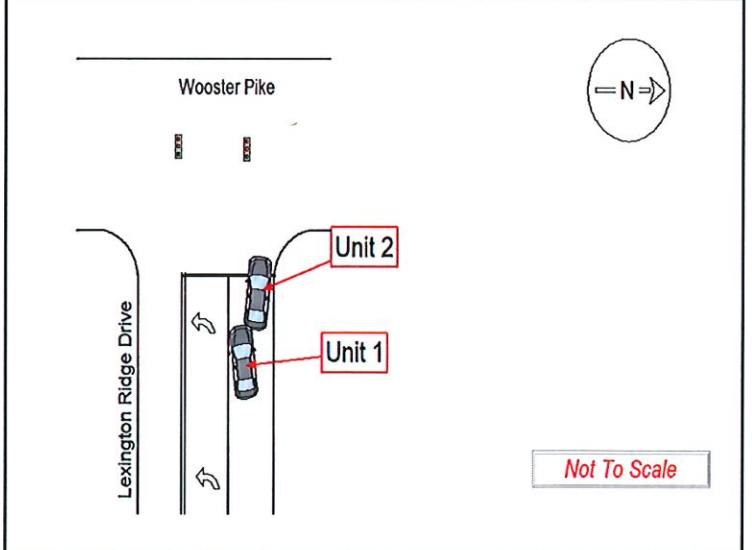

NARRATIVE  
Unit 2 was stopped on Lexington Ridge Drive to make a right turn onto Wooster Pike. Unit 1 attempted to stop on Lexington Ridge Drive, and slid on ice, striking the driver side rear bumper of Unit 2. Unit 1 sustained minor scratches to the passenger's side front bumper. Unit 2 sustained functional damage (dented, scratches, broke free from fender) to the driver's side rear. No injuries were reported and both vehicles were driven from the scene. The driver of Unit 1 was issued a citation for ACDA.
