Unit #2, realizing traffic had not begun to go, hit its brakes but was unable to stop completely as it lurched forward due to the trailer it was towing. The front end of Unit #2 then struck the rear bumper of Unit #1. No injuries were reported and both vehicles sustained minor damage. 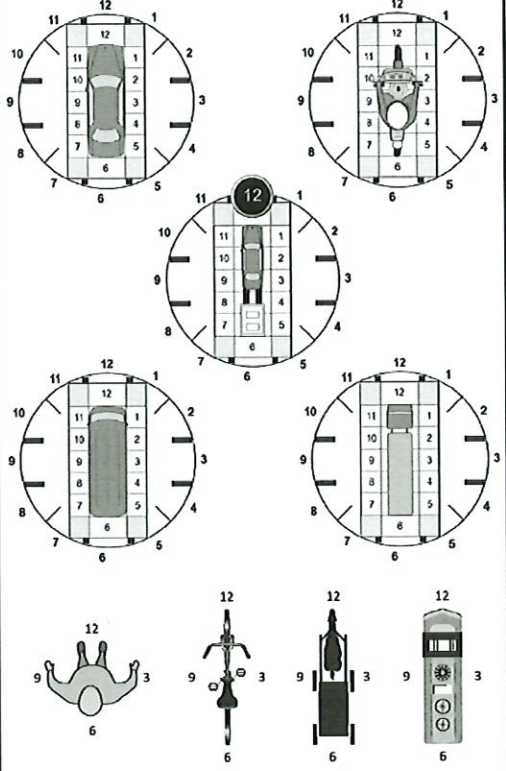
