The vehicle was traveling too fast for the icy conditions and the driver determined that the vehicle could not stop before entering the intersection. The driver choose to steer the vehicle off the south side of the roadway, onto the grass, to avoid a potential collision with vehicles traveling on State Route 57. While traveling on the grass, Unit #1 struck the stop sign on the southwest corner of the intersection.
