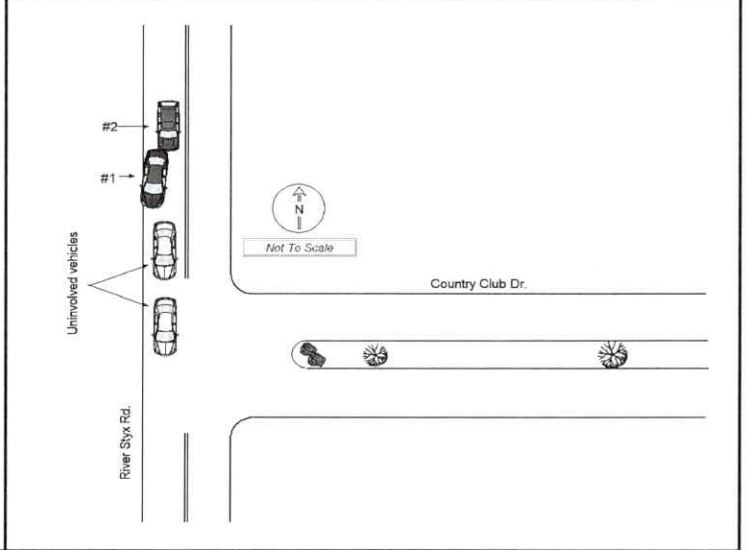

NARRATIVE

Unit #1 was southbound on River Styx Rd., just north of Country Club Dr., when two cars in front of him slowed/stopped very abruptly. In an attempt to avoid a rear end collision, the driver of Unit #1 braked hard and swerved to the right, going slightly off the roadway. The driver of Unit #2 was also southbound on River Styx Rd., directly behind Unit #1. She was unable to stop in time and struck the rear of Unit #1, which sustained functional damage to the entire rear. Unit #2 sustained minor damage to the RF bumper. No injuries were claimed at the scene and neither vehicle required a tow. The driver of Unit #2 was cited for ACDA.

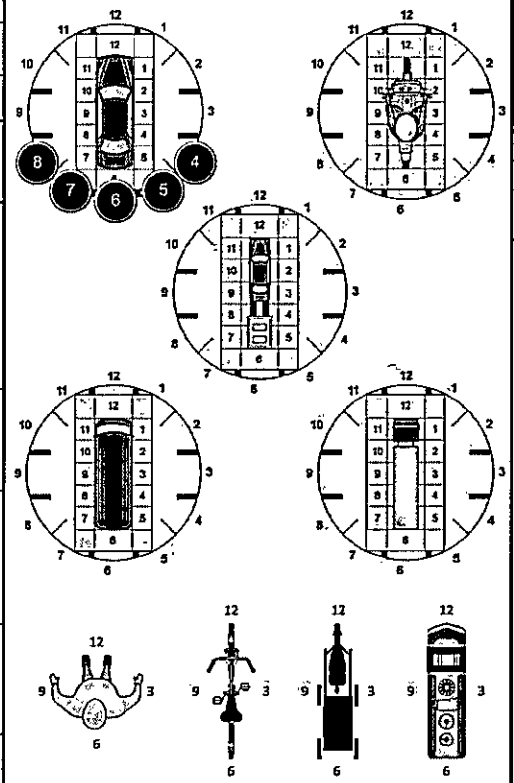

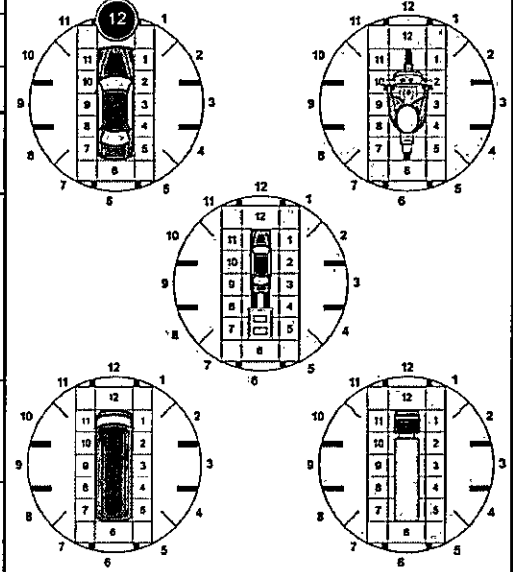
