

NARRATIVE

Unit #1 was stopped at the stop sign on Poe Road at the intersection of Wadsworth Road (State Route 57), facing west. Unit #2 was southbound on Wadsworth Road, approaching the intersection of Poe Road. Unit #3 was stopped at the stop sign on Poe Road at the intersection of Wadsworth Road, facing east. Unit #1 failed to yield and entered the intersection into the path of Unit #2. Unit #2 struck Unit #1, causing damage to both vehicles. Unit #1 rotated clockwise and then struck Unit #3, causing damage to both vehicles. Unit #1 then rolled a short distance to the north, coming to final rest facing north on Poe Road. Unit #1 and #3 were towed from the scene, Unit #2 was driven from the scene.






