NARRATIVE Units 1 & 2 were both southbound on Normandy Park Dr. in parallel lanes. Unit 2 was in the easternmost southbound lane preparing to turn left onto an intersecting roadway, and Unit 1 was in the lane directly next to Unit 2. Unit 1, an EV, was looking for an EV charging station, and decided to turn at the last moment into the same intersecting roadway that Unit 2 was preparing to turn into. Unit 1 attempted to change lanes, failing to see Unit 2, and sideswiped the vehicle. The impact caused minor damage to both vehicles. No injuries were reported, and both vehicles were able to be driven from the scene.

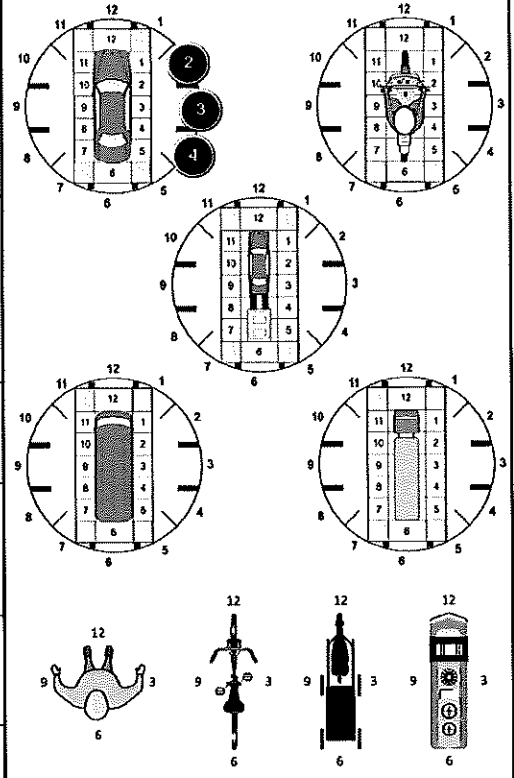
