NARRATIVE Unit 1 was traveling west on Ridgewood Road. The roadway was snow-covered and icy. As Unit 1 crested the hill, it encountered another vehicle backing down the same hill in the westbound lane. Unit 1 tried to stop and slid off the right side of the roadway into the ditch at 3019. Unit 1 sustained functional damage to the passenger front bumper. Jon's Towing removed Unit 1 from the ditch, and the owner drove it home. No injuries were reported.
