

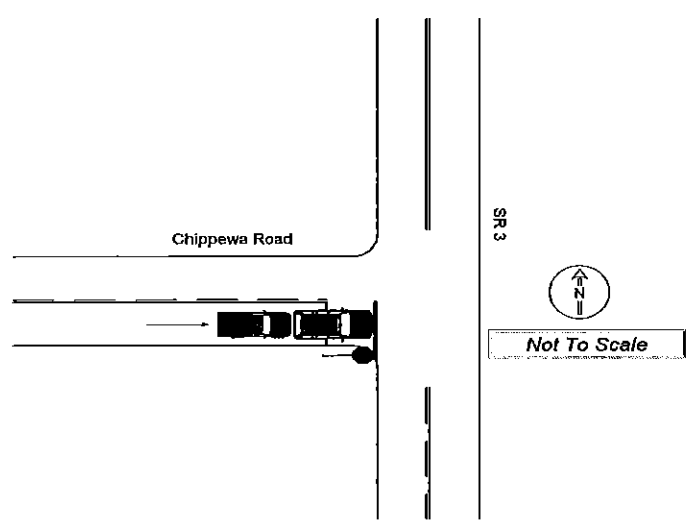

Unit #1 was waiting for traffic to clear up on SR 3 so they could proceed and while doing so, unit #2 thought they were going through so unit #2 proceeded while unit #1 was stopped. As soon as unit #2 realized unit #1 did not proceed, unit #2 could not stop in time resulting in the rear-end accident. The driver of unit #1 stated he may have minor injuries but he refused medical attention from us, he stated that he would take himself to the VA hospital. No other injuries were reported.

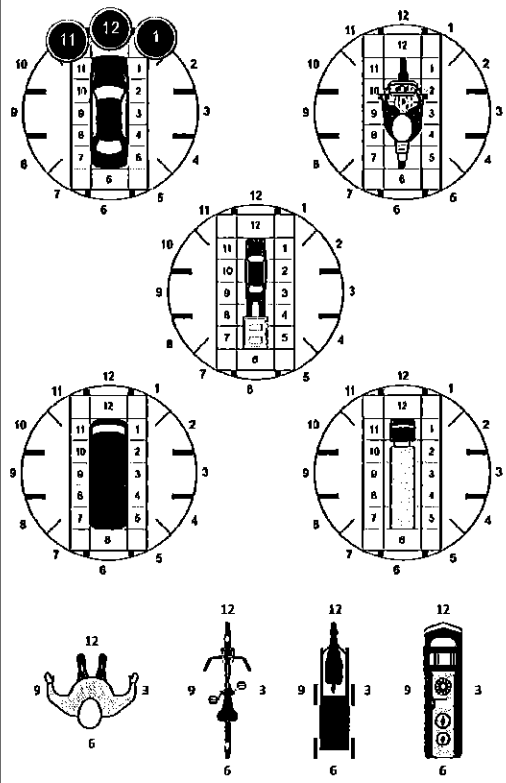
