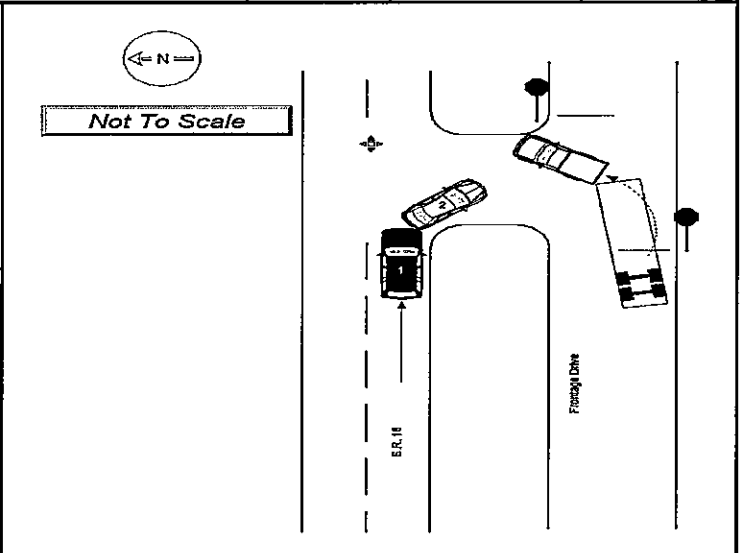

NARRATIVE

Unit 2 was attempting to turn onto Frontage Drive from S.R. 18. Unit 2 had stopped in traffic to allow for an unidentified pickup truck and trailer to continue through the intersection of Frontage and Medina heading eastbound to northbound. While Unit 2 was slowing in traffic, Unit 1 struck Unit 2. Unit 1 was unable to slow down enough and therefore had struck Unit 2 that was inside of the lane of travel of Unit 1 attempting to negotiate its turn. Unit 1 and Unit 2 sustained functional damage. Unit 1 was cited with ACDA. Both driver's refused medical and tow services.

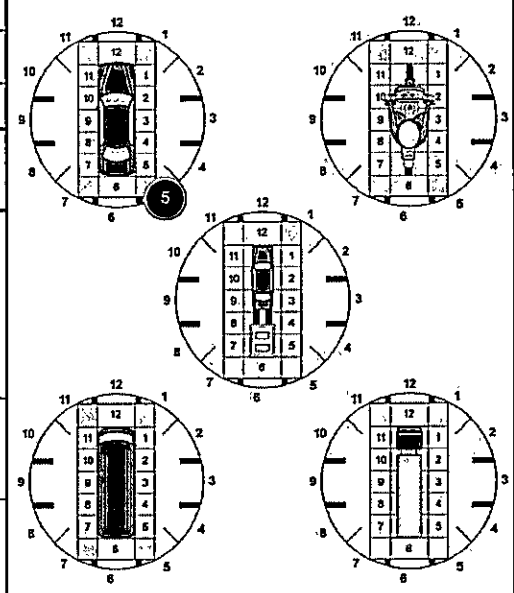

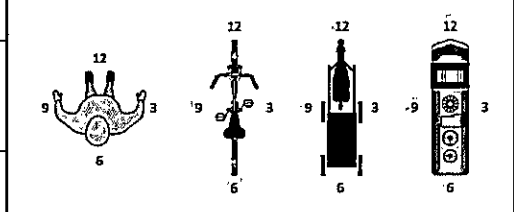
