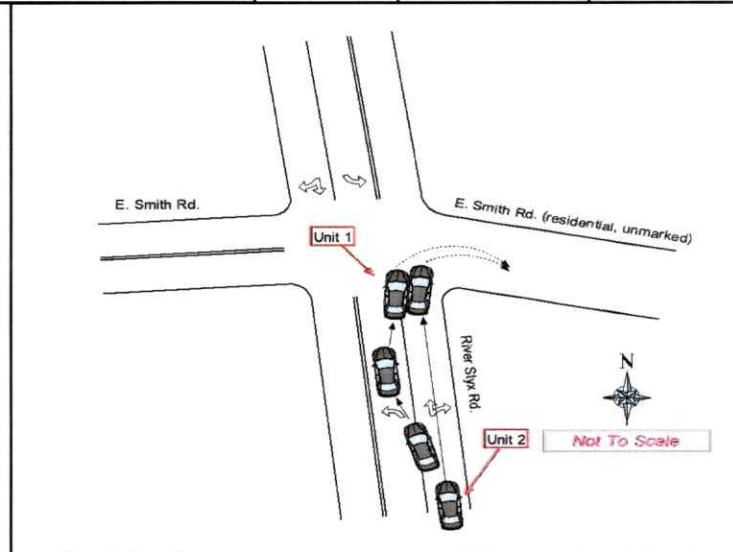

NARRATIVE
Unit 1 was northbound on River Styx Road, and Unit 2 was behind, also northbound. The driver of Unit 2 stated that Unit 1 merged into the left turn lane of River Styx at the intersection of E. Smith Rd., then as Unit 2 began to overtake on the right, while maintaining its lane and continuing north, Unit 1 attempted to change lanes back, or turn right onto E. Smith Rd., striking Unit 2 in a same-direction side swipe crash. Both units pulled onto E. Smith Road to examine damage, at which point the driver of Unit 1 returned to her car, and left the scene. She contacted dispatch a short time later and refused to identify herself. She was identified through follow up investigation, and was cited for the lane change violation, which is consistent with the damage on the units and her admission of attempting to turn right. She was also cited for leaving the scene of an accident. An investigative report was completed in addition to the OH-1.

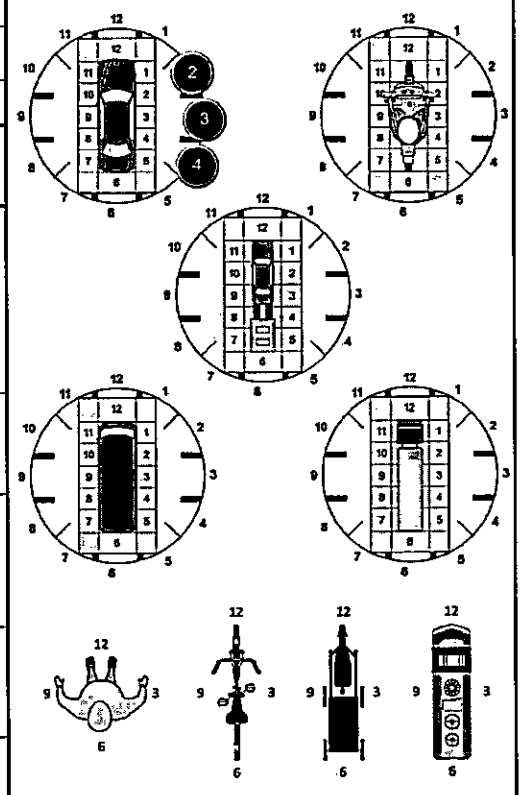
