NARRATIVE

Unit 1, a concrete mixer, was eastbound on Ridgewood Road. Unit 1 veered off the road to the right into the soft shoulder, which pulled the loaded cement mixer into the ditch, causing it to roll onto the passenger side. The driver was able to self-extricate through the broken windshield. He sustained minor injuries, and was transported to the hospital by LST Medic 5. The driver was cited for failing to maintain reasonable control.
