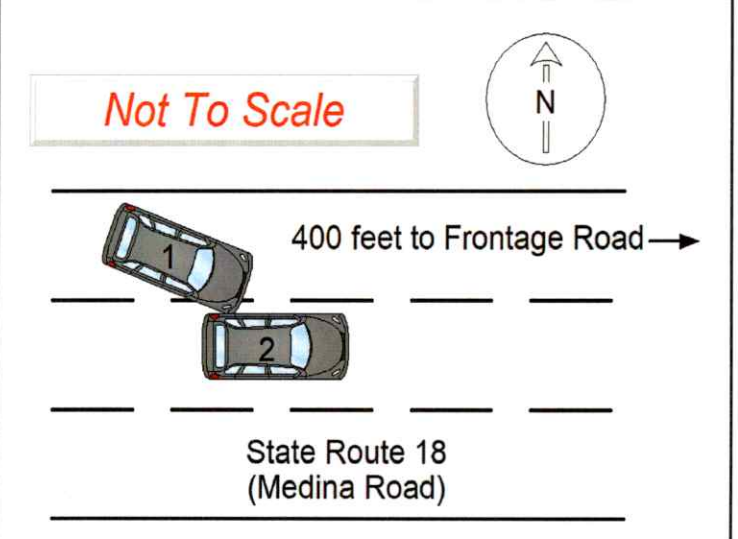

NARRATIVE

Unit #1 was eastbound on State Route 18 (Medina Road) approximately 400 feet west of Frontage Road, in the left and northern most lane of travel. Unit #2 was also eastbound on State Route 18 (Medina Road) but in the center lane, and passing by Unit #1. Unit #1 changed lanes, moving into the center lane, and struck Unit #2 as it passed by, causing minor damage to both vehicles. Both vehicles were moved prior to law enforcement arrival.
