UNIT 1 DRIVER WAS FEELING ILL AND ATTEMPTED TO TURN FROM EASTBOUND MEDINA ROAD ONTO SOUTHBOUND BUEHLER'S DRIVE AND LOST CONCIOUSNESS. DRIVER CONTINUED THE TURN AND WENT OFF ROADWAY RIGHT AND CONTINUED THROUGH A GRASS FEILD BEFORE STRIKING A POLE AND COMMING TO FINAL REST AGAINST THE POLE. DRIVER WAS TRANSPPRTED BY LST TO MEDINA HOSPITAL AND VEHICLE WAS TOWED BY TRANS COUNTY TOWING. NO OTHER INJURIES TO DRIVER REPORTED.
