NARRATIVE Unit #1 was northbound on Wooster Pike, and was slowing. almost to a stop, for stopped and slowing traffic near the intersection of Chippewa Rd. and Wooster Pike. Unit #2 was directly behind unit #1 and was unable to maintain assured clear distance between itself and Unit #1, causing it to strike Unit #1 in the rear. This collision caused minor damage to the rear of Unit #1 and disabling damage to the front of Unit #2, Both vehicles were able to pull off of the roadway and into 7249 Wooster Pike. No injuries were claimed at the scene and the driver of Unit #2 was cited for ACDA. The driver of Unit #2 was able to push the vehicle into the NW corner of the lot, where it would stay until he arranged a private tow.
