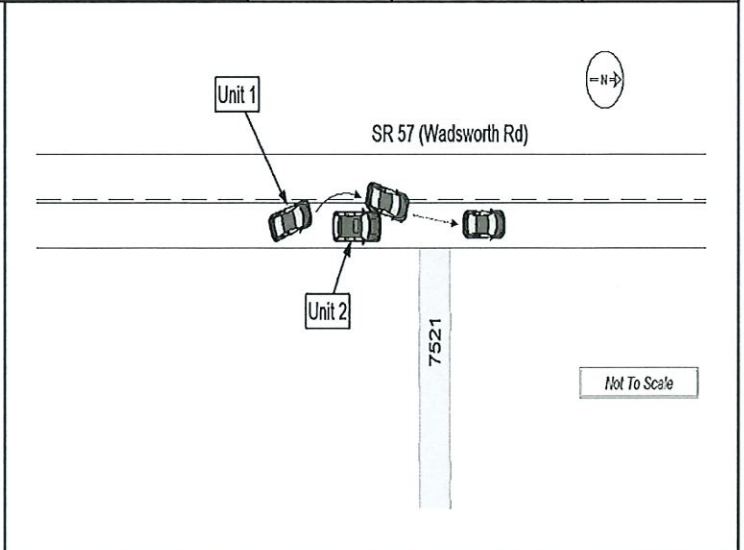

NARRATIVE  
Unit 1 and Unit 2 were traveling north on Wadsworth Road in the 7500 block. Unit 1 passed Unit 2 in a no passing zone near 7521, striking the driver-side mirror, front fender, and bumper of Unit 2 as it merged back into the northbound lane. Unit 2 sustained a broken driver-side mirror and functional damage to the front fender and bumper. Unit 1 sustained minor scratches on the passenger mirror and functional damage to the passenger rear fender, bumper, and rubber transfer to the rear aluminum wheel. No injuries were reported, and both vehicles were drivable. The driver of Unit 1 was issued a citation. Unit 1 did not stop after the accident but reported the accident shortly after. The driver of Unit 1 provided a differing statement about how the crash occurred, but the physical evidence did not match her allegations.
