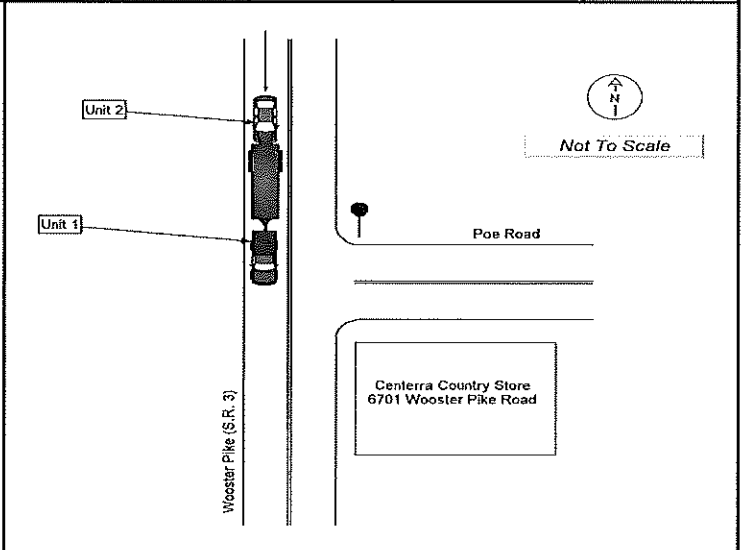

NARRATIVE

Units 1 and 2 were traveling southbound on Wooster Pike Road when Unit 1 abruptly slowed for a stopped vehicle ahead. Unit 2 was unable to stop in time, resulting in a rear-end collision. The front bumper and hood of Unit 2 struck the rear of Unit 1's utility trailer.

Both drivers exchanged information, but Unit 1 left the scene. I contacted Unit 1's driver and instructed him to return to the crash scene to complete the crash report. The collision caused significant, disabling damage to Unit 2, rendering it inoperable. Unit 1's trailer sustained minor cosmetic damage.

The driver of Unit 2 complained of seatbelt burns and a hand laceration but declined medical attention. Unit 1's driver was uninjured. The driver of Unit 2 was cited for failure to stop with an assured clear distance ahead. Bear's Towing removed Unit 2 from the scene.

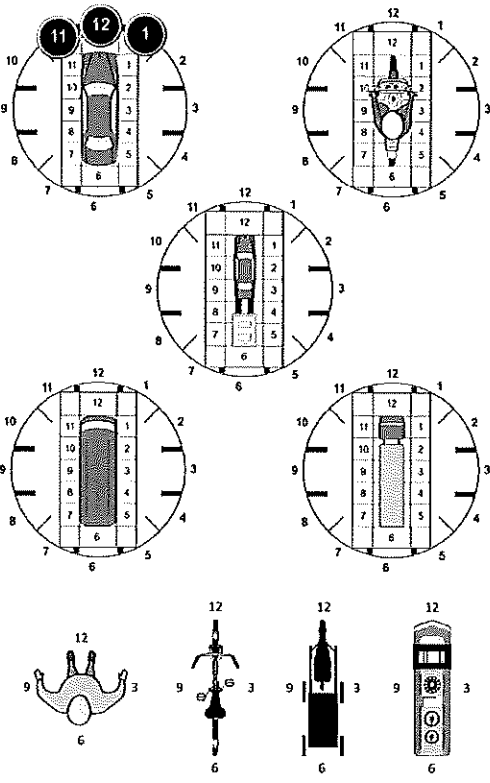
