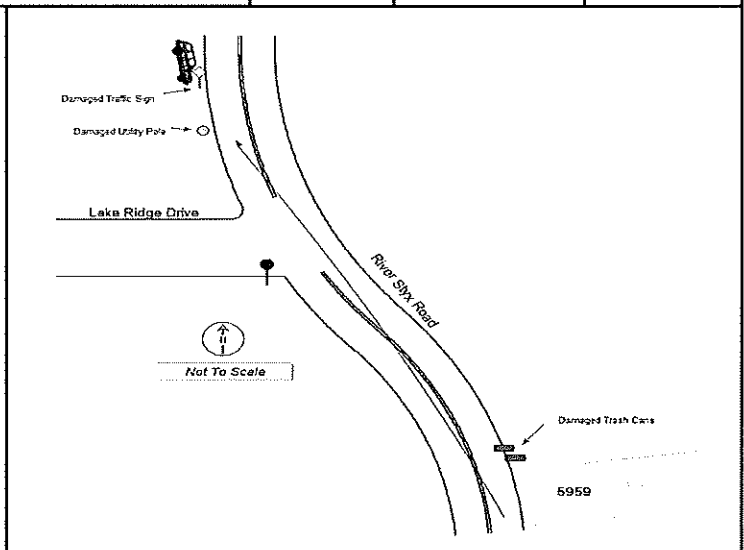

NARRATIVE

Unit #1 was driving north on RiverStyx approaching Lake Ridge Drive. The driver stated a deer ran in front of his car and he swerved to miss the deer and lost control possibly hitting two trash cans around the area of 5959 River Styx. The driver was unable to gain control of the vehicle and struck a utility pole breaking it in half, rolling over the vehicle, and hitting a street sign before coming to rest on the vehicles driver side on the west side of River Styx just north of Lake Ridge Drive. The driver was trapped inside but was able to crawl out through the trunk with officer assistance. Driver was evaluated on the scene by medics and the driver declined transport to the hospital.
