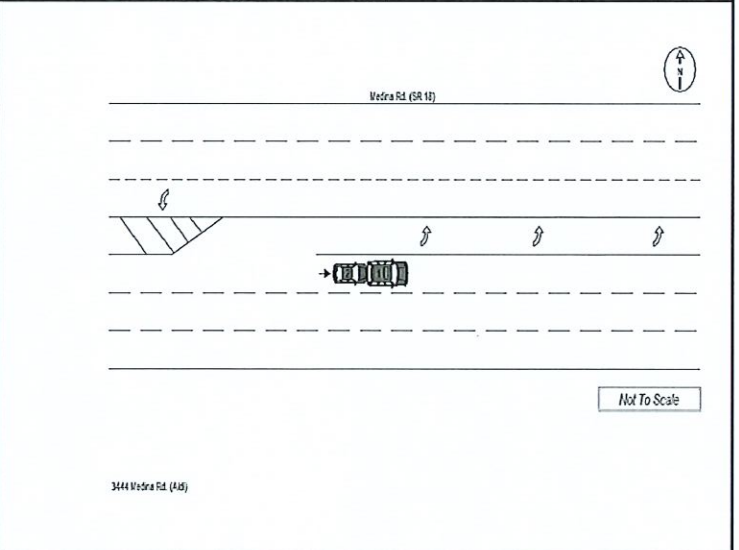

NARRATIVE
Unit #1 was eastbound on Medina Rd., in the 3400 block in front of Aldi, and stopped in traffic due to a red light at Frontage St. Unit #2 was also eastbound and stopped behind Unit #1. The light at Frontage St. turned green and Unit #2 accelerated into the rear of Unit #1 causing functional damage to both vehicles. The driver of Unit #1 complained of possible injury, but was not evaluated at the scene. The driver of Unit #2 was cited with ACDA and both vehicles were driven from the scene.

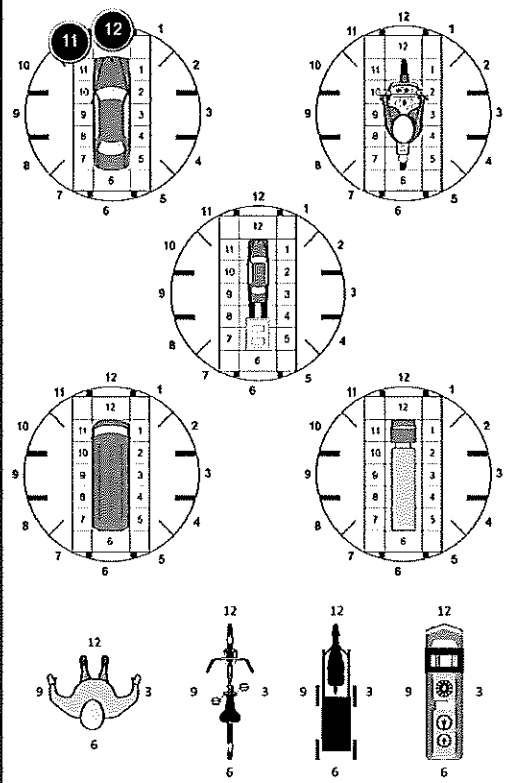
