NARRATIVE Unit 3 was stopped in traffic attempting to turn into 1105 S. Court from S.R. 3 northbound. Unit 2 was stopped behind Unit 3. Unit 1 failed to observe that Unit 2 was stopped in traffic and attempted to brake but was unsuccessful, thus striking Unit 2, which caused Unit 2 to strike Unit 3. Unit 1's driver was transported to Medina Hospital and was cited with ACDA. Unit 1 was also towed by Heidi's. Unit 2's driver and back seat passenger were transported to Medina Hospital, while the front passenger was released to family. Unit 2 was towed by Lloyd's. Unit 3 denied medical and was able to be driven from the scene.

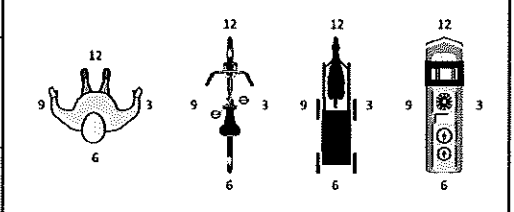
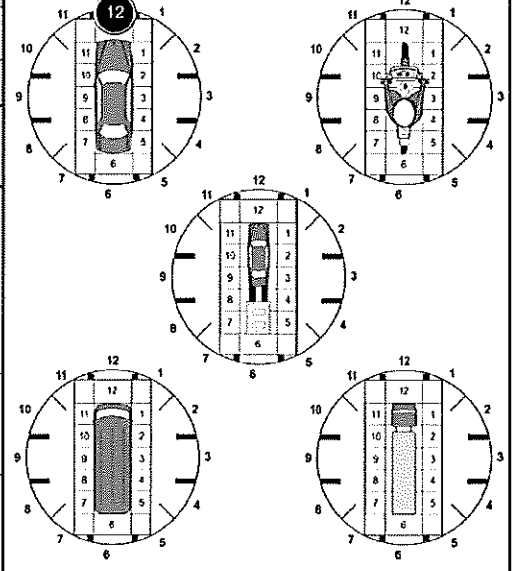
