NARRATIVE  
Unit one was northbound on Wadsworth Rd. when it traveled off the roadway to the right and struck a tree. 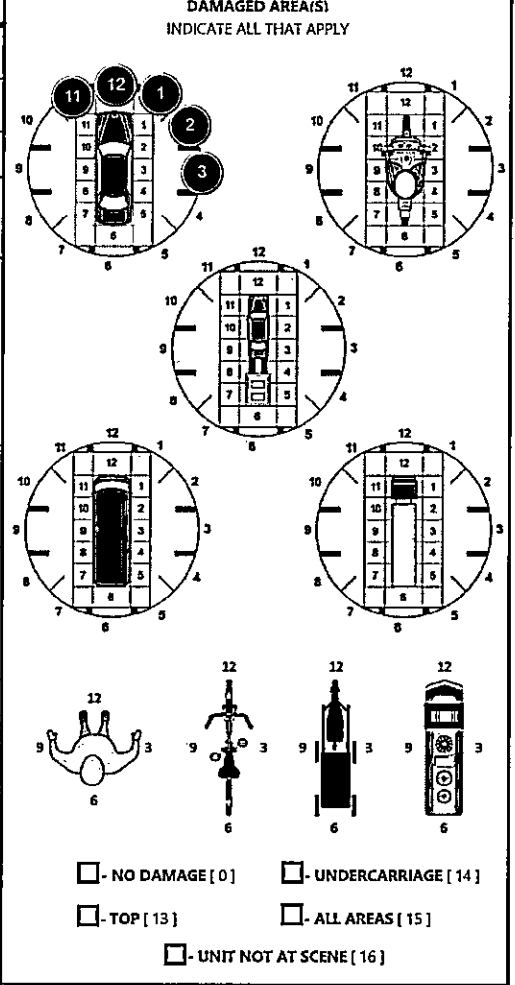
