NARRATIVE Unit # 1 was northbound on State Route 3 (Wooster Pike) in the 5800 block, approaching the parking lot entrance for Dunkin' Donuts and Taco Bell. Unit #2 was exiting that parking lot, intending on continuing south on Wooster Pike. Unit #2 entered the roadway directly into the path of Unit#1. Both units struck each other, causing disabling damage to each unit. After impact, Unit #1 turned to the left and came to final rest in both the northbound and center turn lanes.
