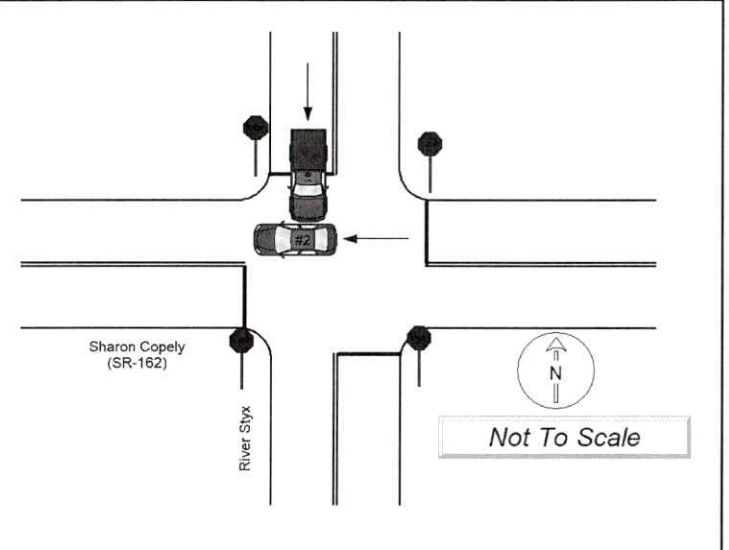

NARRATIVE  
Unit #1 was southbound on River Styx Rd and unit #2 was westbound on SR-162. Both units were stopped at the stop sign at the intersection but unit #2 was stopped at the stop sign prior to unit #1. Both units went through the intersection at the same time causing unit #1 to strike unit #2 on the rear passenger side of the vehicle causing disabling damage and airbag deployment. Driver of unit #1 stated he did not see unit #2 at all until he hit him, and unit #2 was well established in the intersection. No injuries were claimed. Unit #2's vehicle was towed from the scene, and the driver of unit #1 was cited.

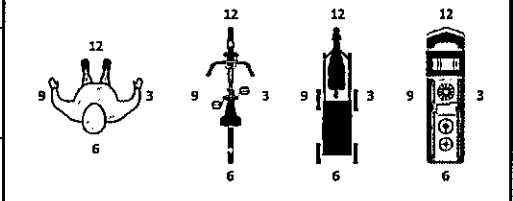
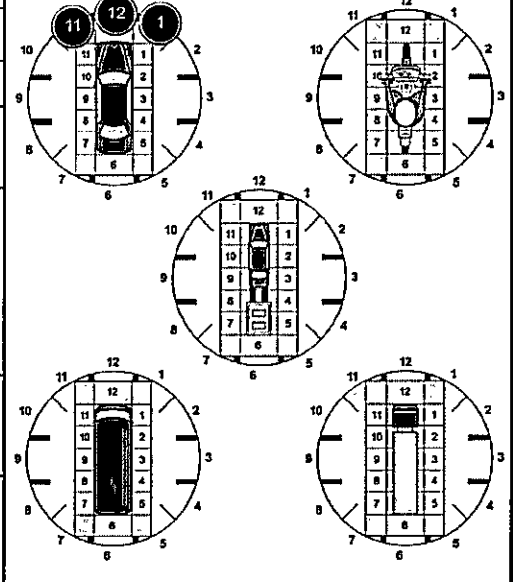

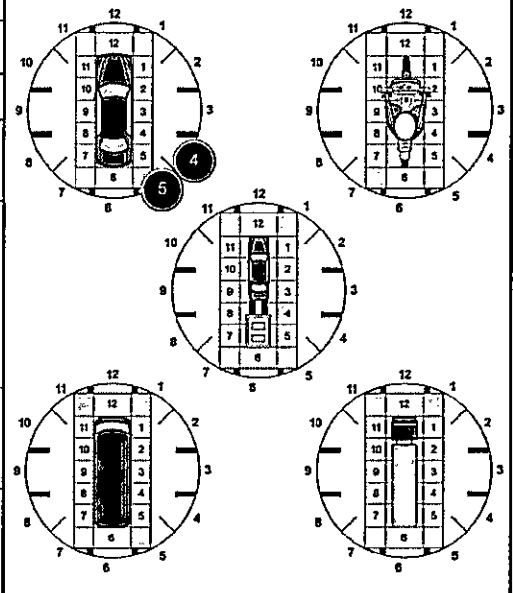
