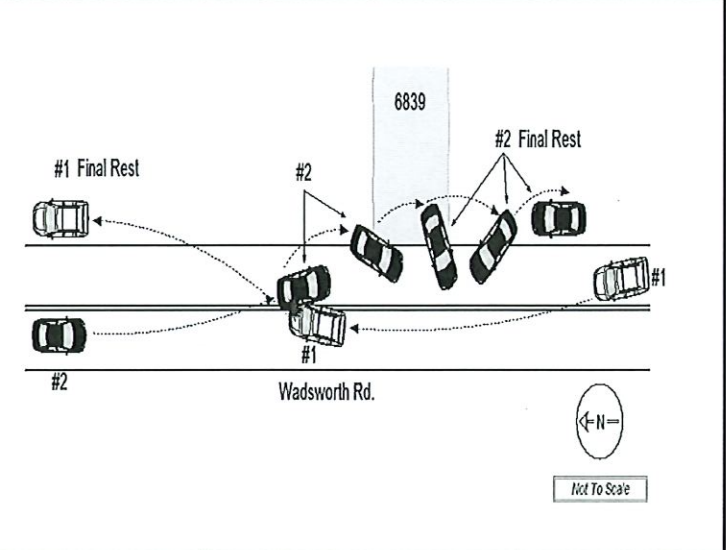

NARRATIVE

Unit #1 was northbound on Wadsworth Rd. in the area of 6839 Wadsworth Rd. The driver of Unit #1 later stated that he suffered a medical episode and blacked out at the wheel, causing Unit #1 to drift left of the center line and directly into the path of oncoming traffic. Unit #2 was southbound at or about the same time as Unit #1 crossed the center line. The driver of Unit #2 made an evasive maneuver to the left to avoid a head-on collision. This caused Unit #1 to strike the passenger side rear of Unit #2, causing it to spin and come to final rest facing north in the eastern-most road ditch. Unit #1 veered back to the right and also came to rest in the eastern-most road ditch facing north. The right rear passenger of Unit #2 sustained possible minor injuries and was transported to Medina Hospital by LST Medic 5. The driver of Unit #1 was evaluated at the scene and declined transport to a medical facility. He was issued a citation for ORC 4511.26(A). Both vehicles required recovery from the scene.

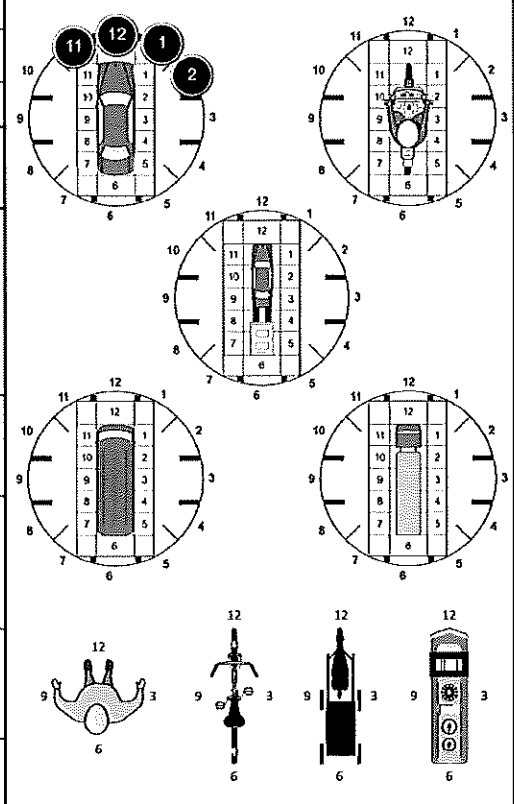

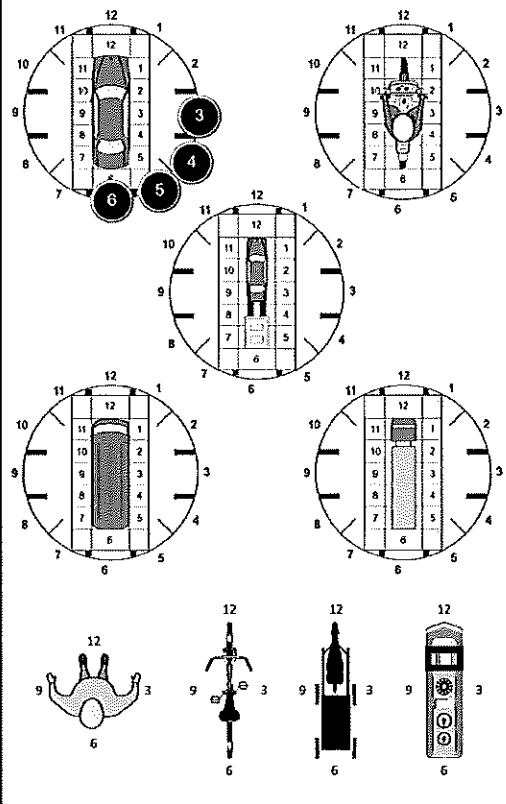
