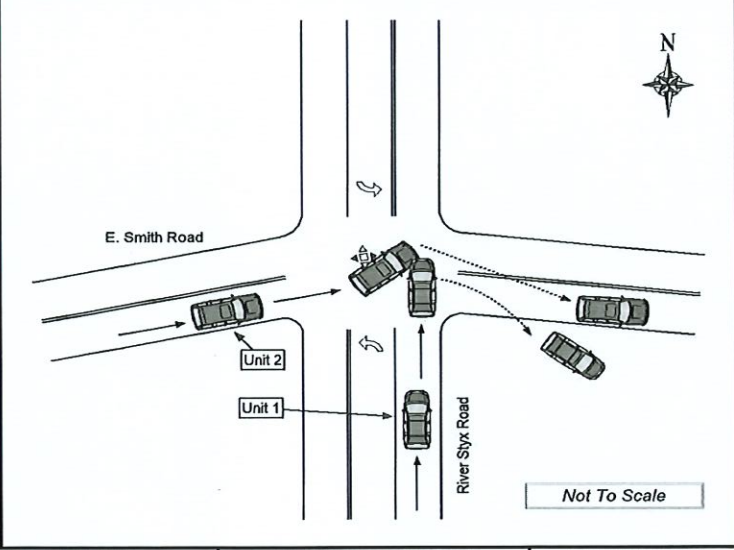

NARRATIVE

Unit 1 was northbound on River Styx Rd, nearing the intersection of E. Smith Rd, where the signal controlling the intersection showed green going north. Unit 2 was eastbound on E. Smith Rd., and did not stop at the red light controlling east/west traffic, and entered the path of Unit 1. The units collided, and Unit 1 spun to face east on E. Smith Rd., then went off the road into the front yard of a residence. No injuries were reported, and the driver of Unit 2 was cited for the red light violation. Both vehicles were towed from the scene.

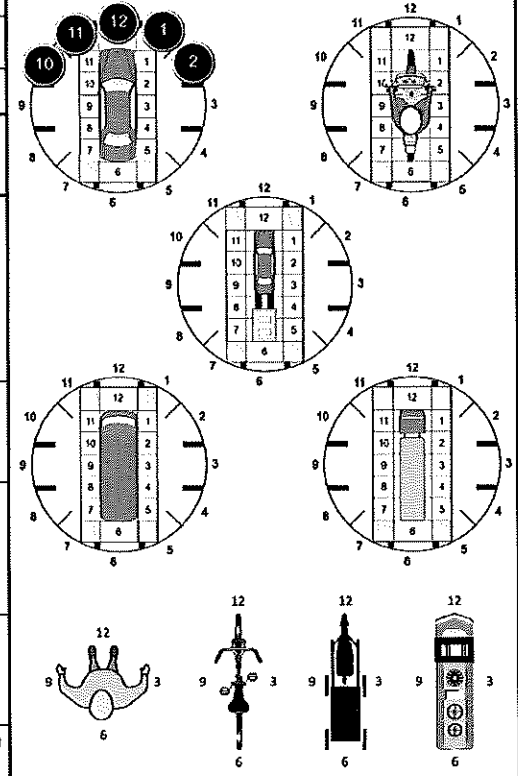

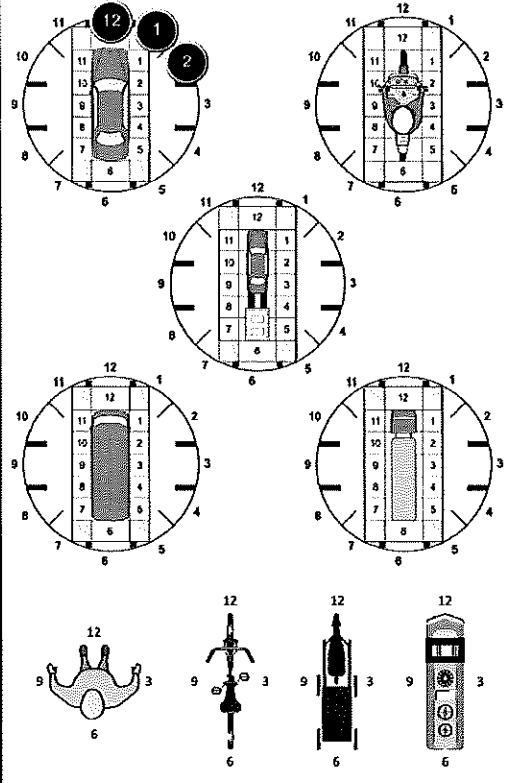
