NARRATIVE Unit #2 was westbound on Medina Rd. and turning left onto to Frontage Dr. at the green turn arrow. Unit #1 approached the intersection on Medina Rd. while traveling eastbound and drove through the red light striking Unit #2. Both vehicles sustained disabling damage, and both drivers were transported to Medina Cleveland Clinic via LST. There were two witnesses to the crash one in front of Unit #2, and the other behind Unit #1, and both witnesses advised Unit #1 drove through the red light.


