Unit 2 struck the driver's side of Unit 1 and then continued off the southwest corner of the intersection. Unit 2 came to rest on the driver's side of the vehicle. Unit 1 continued off the northeast corner of the intersection. The driver of Unit 2 had to be extricated by the fire department and was check by LST. He declined being transported to the hospital. Both vehicles were towed from the scene.

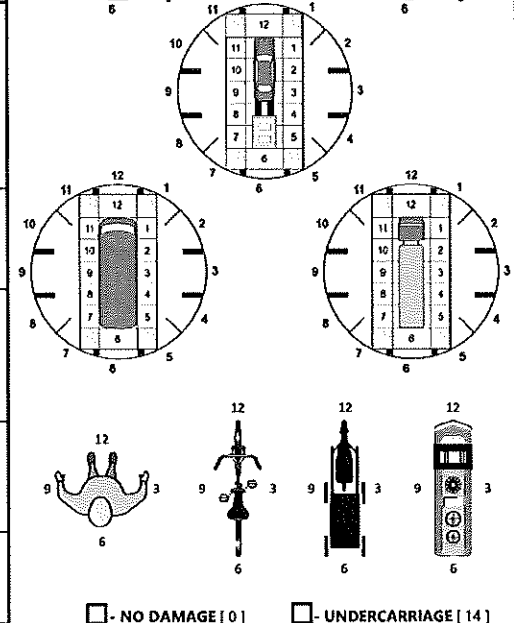

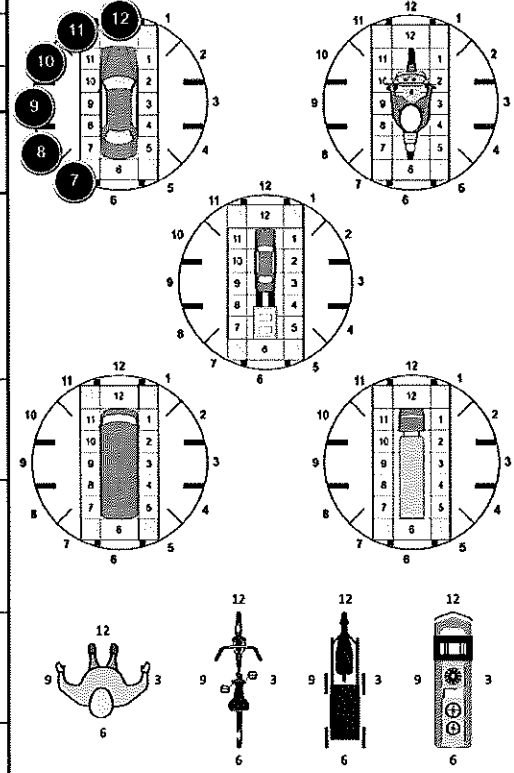
