NARRATIVE Unit #1 (dirt bike/ Rps X-Pro Hawk) was eastbound on Sharon Copley Rd. in the 3200 block. Unit #1's back tire caught some of the gravel on the south side of the roadway and lost control. Unit #1 then lost control and went down causing it to cross into the westbound lane of travel and come to rest where a witness stopped and assisted. Functional damage was caused to the speedometer and left side mirror. The juvenile driver of Unit #1 temporarily lost consciousness at the scene, but regained it and was transported to Medina Hospital by Medina Life Support Team. The juvenile driver of Unit #1 was then transported to Akron Children's Pediatric Hospital trauma center due to the extent of his injuries. Unit #1 was towed by Bear's Towing.


