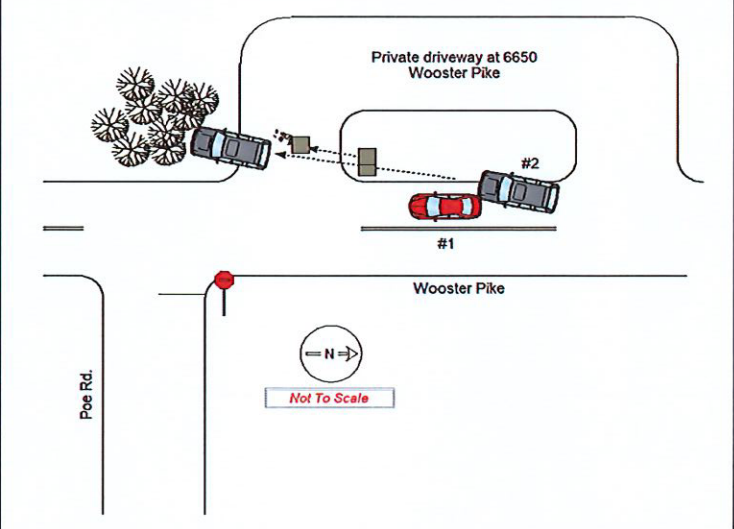

NARRATIVE Units #1 and #2 were southbound on Wooster Pike, approaching Poe Rd. Unit #1 was slowing in traffic and Unit #2 began to slide toward the back of Unit #1, due to slippery roadway conditions. In an attempt to avoid a rear end collision, the driver of Unit #2 veered to the right and just barely scraped the rear bumper of Unit #1, causing cosmetic paint scuffing to the rear bumper area. Unit #2 continued off the right side of the roadway and through the front landscaping of 6650 Wooster Pike, striking both small and large rocks and boulders. It then struck a stacked-stone concrete light post (dislodging it) and came to final rest in a wooded area to the south of the driveway of 6650 Wooster Pike. This caused disabling front and undercarriage damage to Unit #2. No injuries were claimed by any party at the scene. Heidi's Towing recovered the vehicle. The driver of Unit #2 was issued a citation for ACDA. All five of the occupants of Unit #2 were transported by Sgt. Gaede and me to the Montville Police Department where they arranged for a ride home to Ashland, Ohio. 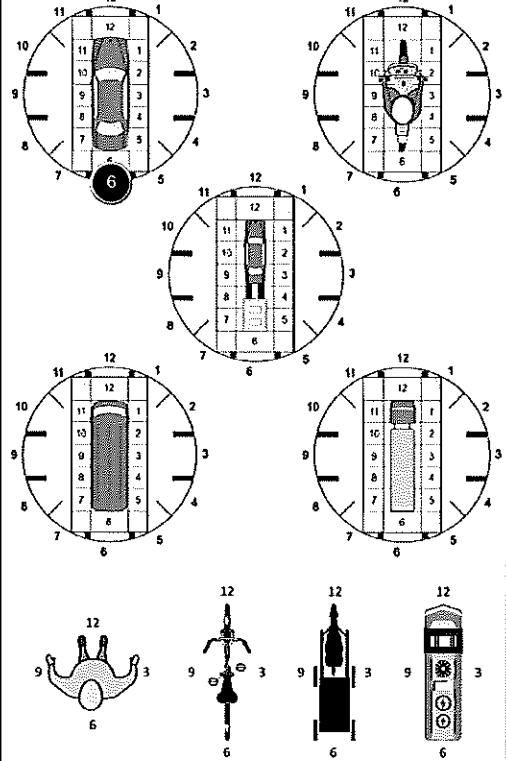

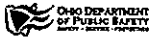
