

 Units 1, 2, and 3 were eastbound on Ridgewood Rd, when Unit 3 began to pass Units 1 and 2. As Unit 3 reached Unit 2, Unit 2 began to change lanes to the left to pass Unit 1 as well, striking Unit 3 in the passenger side. Unit 2 accelerated striking Unit 1 in the rear, and then ran off the road right into the woods.


