Unit #1 drove through a bed of river gravel, over a mulch bed with various perennial plants, struck a structural block pillar and a black aluminum picket-style fence, causing damage to all of the aforementioned property. Unit #1 also sustained functional damage to the front and likely the front underbody area, causing it to need a winch-out, which was provided by Bear's Towing. Once pulled back onto the roadway, the vehicle was deemed able to be driven to the driver's residence, which was within the Fox Meadow neighborhood and only a very short distance away. No injury was claimed at the scene. The driver was issued a citation for ORC 4511.202, failure to maintain reasonable control and a warning for his expired registration. A member of the HOA board was contacted regarding the damage to the property.
