

NARRATIVE  
 Unit #1 was stopped at the eastbound Medina Rd. exit of GetGo (3080 Medina Rd.) waiting for eastbound traffic to pass. Unit #2 came up behind Unit #1 and pulled to the left of Unit #1, creating a two-lane exit, which it is not. The driver of Unit #1 admitted to giving the driver of Unit #2 "the finger", and, as depicted on GetGo surveillance video, the vehicles pulled out at or about the same time onto Medina Rd. and started eastbound. Unit #2 accelerated past Unit #1 and, during the overtaking, the two vehicles collided. The left front of Unit #1 contacted the right rear of Unit #2, however it is inconclusive as to which driver was at fault. The drivers pulled into 2736 Medina Rd. and engaged in a shouting match, both denying being at fault in the collision. No injuries were claimed at the scene. There is no proof of insurance for the Ford van (Unit #2) as of the date of the crash. It was obtained on 10/20/2025 through State Farm. The driver of Unit #2 was found to be under a license suspension and was cited for it on 10/21/2025. It should be noted that the driver of Unit #2 was cited with 4510.111(A) which is a code section that does not exist in this crash reporting software. As a result, 4510.11 was used instead.


