

NARRATIVE

Units #1 and #2 were both traveling eastbound on Medina Road with Unit #2 in the continuous merge lane from River Styx Road and Unit #1 one lane to the north. Both drivers stated the other merged into their lane and neither claimed responsibility. There was no proof as to which driver was at fault. Both vehicles sustained functional damage not requiring tow, and no injuries were reported.
