Unit 1 was making a right turn onto Lexington Ridge Dr. from Wooster Pike and while making the turn slid into Unit 2 which was stopped in the left turn lane at the stop light on Lexington Ridge Dr. Unit 1 struck Unit 2 in the left front quarter panel with its left front quarter of the vehicle. Both vehicles were drivable and pulled into the Drug Mart parking lot. No injuries were reported.
