

NARRATIVE
Unit #1 was traveling east on Medina Rd. in the southernmost (furthest right) lane. Unit #2 was also traveling east on Medina Rd. in the middle lane next to Unit #1. Unit #2 began to turn right from the middle lane into Sunoco and struck the driver's side front wheel well and door of Unit #1, causing functional damage. It should be noted that Unit #1 had preexisting damage to its front end. Unit #2 sustained functional damage to its passenger's side doors. As a result of its damage and airbag deployment, Unit #2 was towed from the scene by Action Towing. The driver of Unit #1 was checked for injury at the scene by Medina LST, but was not transported. The driver of Unit #2 was cited for marked lanes.
