

NARRATIVE
 Unit #1 was eastbound on Cobblestone Park Dr. in the 4600 block. Unit #1's passenger's side mirror struck the mailbox of 4648 Cobblestone Park Dr. causing damage to the mailbox and cracks to the mirror housing. The driver of Unit #1 advised he attempted to make contact at the residence, but was unsuccessful. He then reported it right away to the Montville Police Department. 
