

NARRATIVE
Unit #1 was on State Route 162 stopped at the stop sign, facing west, at the intersection with River Styx Road. Unit #2 was eastbound on State Route 162 in the intersection with River Styx Road. Unit #3 was northbound on River Styx Road, approaching the intersection with State Route 162. While Unit #2 was within the intersection, Unit #3 entered the intersection and struck Unit #2 on the passenger side. This action caused Unit #2 to rotate clockwise and strike the front of Unit #1 with it's driver side. All three involved vehicles were damaged.
