

NARRATIVE

Unit #1 was westbound on Lexington Ridge Drive, approaching the intersection of State Route 3 (Wooster Pike) in the straight lane with a green light showing. Unit #2 was westbound on Lexington Ridge Drive approaching the intersection of State Route 3 (Wooster Pike) in the left turn lane. As Unit #1 was passing by Unit #2, Unit #2 changed lanes from the left turn lane to the straight lane. This action caused a collision between the vehicles, causing damage to both. Both vehicles were driven to a nearby parking lot, where law enforcement was contacted.





