

NARRATIVE  
 Unit 1 was traveling north on Wooster Pike, approaching the Roundabout at Sharon Copley Rd. Unit 1 continued straight as the roadway curved to the right. Unit 1 crossed into the southbound lane and then ran off the left side of the roadway at 6132. Unit 1 entered a ditch and traveled 250 feet coming to final rest in the yard of 6132. The driver sustained injuries to her nose and was transported by LST Medic 5 to Medina Hospital. Jon's Towing recovered the vehicle. Reba McBride (daughter of driver) was called to retrieve all personal effects from the car per the driver's request. The driver was cited for reasonable control.


