

NARRATIVE  
 Unit #1 was eastbound on High Point Drive approaching Wooster Pike. Unit #2 was westbound on Lexington Ridge Drive approaching Wooster Pike. The light at the intersection was green and unit #2 was about to go through the intersection to continue west onto High Point Drive. At the same time, unit #1 was entering the intersection to turn left to go north on Wooster Pike, causing an accident between both vehicles. Both vehicles had disabling damage and unit #1 had airbag deployment on the front driver side. Drivers of both vehicles advised they were shook up but declined an ambulance.


