

NARRATIVE

Unit 1 and Unit 2 were stopped at a red light in the far right lane of the I-71 northbound off-ramp, both intending to turn east onto Medina Road. The driver of Unit 1 advanced slightly to check for oncoming traffic but stopped again upon realizing the intersection was not clear. The driver of Unit 2 observed Unit 1's initial movement and also looked left to check eastbound traffic; however, she failed to observe that Unit 1 had stopped in front of her. The front bumper and hood of Unit 2 struck the rear hatch and rear bumper of Unit 1. Both vehicles sustained very minor damage and were relocated to Montville Drive to avoid obstructing traffic. Photographs were taken at the scene, and no injuries were reported.





