

NARRATIVE
Unit 1 was traveling eastbound on Ridgewood Road near 3361 when a deer entered the roadway from north to south. Unit 1 struck the deer with the front passenger side. The collision resulted in functional damage to the passenger side headlight assembly, grille, hood, bumper, and fender. No injuries were reported and Unit 1 was driven from the scene.
