

NARRATIVE
 Unit 2 was traveling northbound on Wadsworth Road and stopped for a vehicle ahead that was attempting to make a left turn onto Tower Road. Unit 1 failed to stop and rear-ended Unit 2. Unit 1 sustained functional damage to the front bumper and grille. Unit 2 had no visible exterior damage; however, possible undercarriage damage could not be determined at the scene. The driver of Unit 1 reported no injuries. The driver and occupants of Unit 2 advised that injuries were possible. The driver of Unit 1 was issued a citation for Assured Clear Distance Ahead (ACDA). Both vehicles were driven from the scene.





