

NARRATIVE

Unit #1 was westbound on Poe Rd. approaching the intersection of Wooster Pike. The driver stated a deer ran out in front of his vehicle, causing him to drive off the right side of the road to avoid striking it. No visible damage was observed to Unit #1. Since no deer was struck/injured during the crash, there is no way to prove or disprove the presence of a deer at the time of the crash. Montville Township Service Department was advised of the damage to the ditch and provided a report number.


