

NARRATIVE
 Unit # 1 was southbound on Wadsworth Rd. and was stopped, waiting to turn left onto River Styx Rd. Unit #2 was also southbound on Wadsworth Rd. and was unable to maintain assured clear distance ahead, ultimately rear-ending Unit #1. Unit #2 then careened forward and came to final rest off the left side of the roadway, against a utility pole. No injuries were claimed at the scene. Unit #2 was recovered by Jon's Towing and the driver was cited for ACDA.
