NARRATIVE Unit #'s 1 and 2 were both eastbound on Poe Rd., at or about the 4000 block. Unit #2 was directly behind a garbage truck, which was stopping periodically to pick up trash receptacles. Unit #1, which was directly behind Unit #2, began to pass both Unit #2 and the garbage truck. When it got next to Unit #2, the driver of Unit #2 also decided to pull out in an attempt to pass the garbage truck, sideswiping Unit #1 and pushing it off into the ditch. Unit #1 was recovered from the ditch, and no apparent damage was incurred from driving off of the paved portion of the roadway. Unit #1 sustained damage to the passenger side, including mirror and body damage. Unit #2 sustained minor scraping/body damage to the left front and driver side. It is to be noted that neither party was cited despite both of them violating ORC 4511.27(A)(2). Unit #1 did not audibly signal and Unit #2 did not give way in favor of Unit #1, ultimately increasing his speed (in order to pass). No injuries were claimed at the scene and neither vehicle required a tow.



