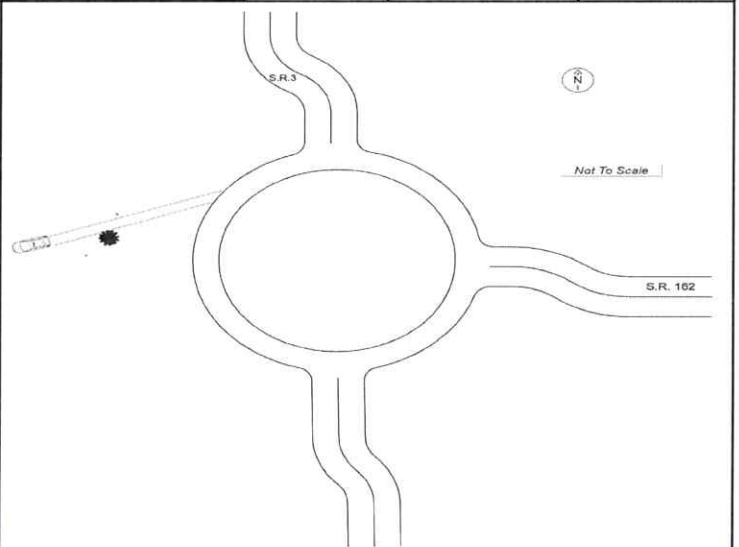

 Unit 1, while attempting to negotiate the roundabout at S.R. 3 and S.R. 162, failed to control the vehicle and went off of the roadway to the west and came to final rest in a wetland area. Unit 1's driver side curtain airbag deployed. Neither driver nor passenger sustained any injuries. The passenger was assessed at the scene by Medina LST, and the vehicle was towed by Jon's Towing. Driver refused medical and refused SFST's. Driver arrested for OVI and refused chemical tests.

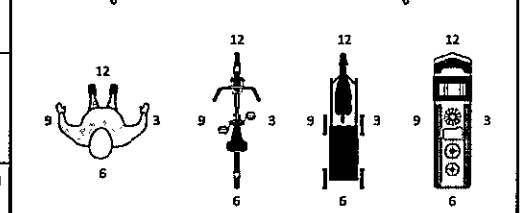
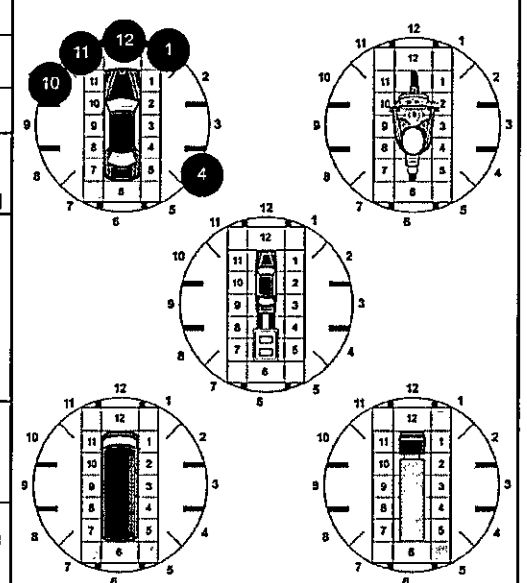
