

NARRATIVE

Unit #1 was southbound on River Styx Road, and the driver advised he doesn't remember what happened. Unit #2 was traveling northbound on River Styx Road and saw Unit #1 enter into his lane. Unit #2 attempted to swerve into the southbound lane to avoid the collision and Unit #1 struck Unit #2. Both vehicles sustained disabling damage and Unit #1's driver and front passenger were transported by EMS to Akron General. The parents of the two juveniles who were rear seat occupants of Unit #1 arrived on scene and drove them to Akron Children's Hospital. Unit #2's driver was escorted to Medina hospital where all three of his passengers were transported by EMS. Unit #1 was towed by Trans County Towing and Unit #2 was towed by Lloyd's Towing.


